
To show how the action areas will contribute to our individual aspirations, we've used some personas - characters who represent a wide demographic of local residents, to see how each area will benefit them.





TRUST MANAGER'S REPORT

BOARD REPORT

The minutes of October's meeting have been ratified and we can share the exciting world of the Stratherrick and Foyers Trust Board to the world!

AGM & INSURANCE

We've been plugging the Trust AGM for a while. It's on 24th November, you know. At this meeting the Board ratified the accounts until end of June 2021. Other matters arising was confirming who is covered by insurance at the Wildside and what groups need to provide their own. We can advise on who to go to if that is the case.

FINANCE

Carlene Vincent gave us our Finance report with the watchful eye of Frank Ellam. Frank stands down as Finance Director at the next AGM and we will be sad to see him thoroughly enjoy his well earned retirement from the Board.

GRANTS

Several Student Grants were awarded, as was a memorial booklet on those fallen who are listed on the war memorial. The grant of £60,517 for Boleskine Community Care and the conditions of grant were approved by the Board too. All grants over £25,000 have to be discussed with our funders, SSE, and we made the case for this to be approved in full. Grants too were considered for the Stratherrick Community Hall and the Community Council and discussions are ongoing.

COMMUNICATION

Our new Communications Strategy was presented to the Board. Much of this was put in place by the work of Jillian Barclay, who is standing down at the next AGM. A vote of thanks was given, as well as noting a 35% engagement rate on the Community Action Plan was in part down to the communication tools that have been developed by Jillian and Gareth over the last twelve months. Board Directors (and members of the community) are advised to check our weekly Project Updates on the website every Thursday.

WILDSIDE CENTRE

The Wildside Team have been going great guns too. Following feedback at the Spring Fair they have changed the priorities on the landscaping project to include a pathway and improved access around the Wildside. A tender document has since been issued and awarded. Petanque Courts, ridge tiles, crockery and waste bins also got a mention. Later on we talked Winter Wonderland planning and hope for a good event for all the family in December. We also have our first wedding coming up, which is nice!

FOYERS TOILETS

A memorandum of understanding has been drawn up between the Trust and the Community Council on the development of Foyers Toilets, the plans for which will be reviewed as costs have escalated for materials.

SMOKE ALARMS

The Board were informed about the Scottish Government Smoke Alarm legislation, work to support people who may have difficulty raising the £300 required and a letter asking if the Trust would purchase the alarms for the whole community at a cost of £75,000. SSE would not support any of the proposals other than agreeing to promote how you can get alarms if you meet a certain criteria and work to see if we can arrange come low cost deals for the community. The funds were not in the budget and something else would have to go if the proposal had been approved. Information will go out the community and can be found in this newsletter.

The meeting was so long we had to adjourn and arrange a second briefing on the Community Action Plan and next steps if people could make it. Most of the actions from that will be made to the community shortly, but expect the Community Action Plan document through your door soon!
