So, apologies from me if you feel that things seem to be moving too fast on any project. Change is scary but I encourage you to make your views known through recognised channels and hopefully we will get the balance right not only on this but future projects too.

## HAVE YOUR SAY ON RIVERSIDE FIELD

We currently have over 50 responses to the Riverside Field survey. This is already a substantial sample from the community that captures and represents your views on the project but please continue to let us know your views here before midnight on 21st June.

We will publish the results and your comments will help guide the Community Steering Group who will take this forward if the project gets through planning. The Trust has facilitated this survey to help capture the community view around the area and closest to the field TODAY, after several years of development work. We will share the results with the community on our website and share with those who have expressed an interest to be on the Community Steering Group and the Directors of the Trust to help reach an informed consensus on how to develop the project. We recognise there are still a few people who feel their voice hasnt been heard and we hope this will help record that in this process. We also think it is very important that people engage with the planning process whether they have a positive or negative view. Three people have taken the opportunity to do so.

Before commenting do read the Design Statement in Documents as that tells the story of how the community got to this point, including the background of the site and all community consultations. Make your views known to the local Planning Department on the Highland Council website and search for Linden Park.

Planning seems scary but it is a useful process. It can clarify facts and highlight potential areas for change. For example, the Flood Risk Management team do not object because of the proposed drainage arrangements.

However, Sports Scotland have suggested an alternative to a manned climbing wall and offered their help for a bouldering option which members of the community may prefer. Other statutory consultees will give their view so we, as community members, get a sense what is and is not acceptable according to policy and planning regulations.

Nick Wright, lead facilitator for the Our Community Our Future community action plan, gives a progress update.


Think back to where we were in February: a blank sheet of paper, with literally no ideas or thoughts of what might constitute 'Our Community Our Future', the Community Action Plan. Now, just 4 months later and with hundreds of responses and ideas from across the community, we're homing in on some really exciting actions for the future. That's exciting!

The journey kicked off in February with the community survey, followed by the first Community Assembly in April, a first round of themed working groups and a second Community Assembly at the end of May. All of these activities have been open to everyone, and we're very grateful to the hundreds of folk who've engaged despite the challenges of working online.




At the time of writing in mid June, we're partway through the second round of themed working groups shown in the graphic. They are open to everyone of course. The purpose is to get to a first go at a draft strategy and actions for the Community Action Plan, for everyone to look at over the summer. The conversations are fascinating.

You can see the draft strategy that's being discussed in the working groups in the diagram below. It's work-in-progress and nobody thinks it's quite right yet, but I'm confident it will get there through more discussion in the working groups and then the draft Community Action Plan.



The next diagram shows the (draft) building blocks of the Community Action Plan. Again, these action areas will change before the draft plan comes out, perhaps significantly, but you should get a flavour of the direction.



The strategy and action areas are very much a first effort. In fact, those diagrams will already have changed by the time you read this, through the conversations in the second round of working groups. But we wanted to give you a taste of what the draft Community Action Plan might contain next month.

If you don't like what you see, it can change. We'll be sharing the draft Plan with the whole community on www.communityfuture.net for comment and review over the summer. That will be everyone's opportunity to consider and comment on the plan in the round. To complement that online engagement there will be a special Youth Club BBQ and we'll also be at the Gala in July, so we won't be relying solely on the website. If we can do more, we will.

By September, we should have a Community Action Plan, refined to take account of all the feedback. We'd like to organise a third Community Assembly at that point: not on Zoom, but a real get together. Fingers crossed.

Please get involved and have your say over the summer. If the plan is to live up to its title, Our Community Our Future, you need to shape it!

#### HIGHER GROUND WIN CONTRACT

The Higher Ground Group have been awarded the Garden Maintenance contract after an open tender process. The Trust were impressed with their 'helping communities stay safe and flourish'. They will soon be maintaining areas at the Wildside Centre, Riverside Field, Foyers Bay and Errogie Chrurch. You can read more about them here

At Riverside Field they will be cutting a pathway through the grass, creating areas to sit and spaces to exercise on and play football. Following feedback from the nearby residents, they have been advised on giving consideration to wildlife when cutting the area.

The Wildside Centre is developing an outdoor seating area and Higher Ground will make it even more attractive as well as sprucing up the grounds around Errogie Church and Foyers Bay.



The contract is for one year at which time the Trust will review the contract and work undertaken by the Group.

Areas to be maintained include the exterior and interior of Wildside, keeping the grass cut and establishing accessible areas in Riverside Field (taking into consideration any local wildlife), areas outside Errogie and Foyers Bay to make sure they don't look to unkempt prior to any works in the area. We'd like to welcome them on board.

#### DIRECTORS LOOK FOR SOLUTIONS AT BOARD MEETING

The Trust Board met on 2nd June and it was a bumper non stop three hours.

The Board agreed to proceed with a new Finance Officer role as it was felt this would become increasingly difficult to maintain as part volunteer/part paid role and with more funds, projects and match funding coming in to support the aspirations of the community. It was agreed paid professional support would be required.

There was a lot of discussion around grants for groups and how we could support what they intended to do whilst maintaining the spirit of the funders requirements, particularly as we come out of Covid restrictions. There was also discussion on plans for the forthcoming Summer Gala to help ease community members into engaging with each other again.

The balance between several years of work on the Riverside Field Development and the considerations of some of the

local residents were addressed as things move into the planning stage. The Trust and the Community Council had been given late notice when the planning application was 'live' so welcome the Community Councils intention for an extension on planning to allow them and the community to engage in that process. The Board also agreed to conduct a survey, capturing the thoughts of the community as a whole and all the nearby residents thoughts, which will be shared once it ends on 21st June. The intention is to also capture those who are interested in the project for a Community Steering Group who will give consideration to any planning conditions and findings of the survey and help develop the project and advise the Directors moving forward.

Reference to the Community Action Plan was made and the process taking place. Action Groups end in June and there will be discussions with Nick Wright and his team about next steps.

Sadly we have lost some Directors due to work pressures and there is a recognition that groups are struggling for volunteers and momentum after the pandemic so thought will be required how to engage with, support and take forward future projects.
